

CONSTITUTION RVerS OF IDAHO

Approved 6/14/2024

ARTICLE I

NAME

The name of this organization, established on January 1, 2023, shall be RVerS of Idaho.

ARTICLE II

PURPOSE

The purpose of RVerS of Idaho is to promote good practices of recreational camping, bring together people of similar interests, work to protect Idaho recreational camping, and support charitable activities around Idaho.

ARTICLE III

DEFINITIONS

Section 1. The term "state" or "club" means the RVerS of Idaho state organization.

Section 2. The term "chapter" means a duly chartered chapter of the state organization.

Section 3. the term "membership" means an entity that pays state dues; the term "member" is an individual.

ARTICLE IV

AUTHORITY

In order to achieve its purpose the club may:

- Establish/charter local chapters
- Open a bank account in the club's name
- Collect membership dues
- Take out insurance
- Organize and manage events
- Hire staff with executive board approval
- Work with other groups and exchange information
- Do other lawful activities to promote its purpose

ARTICLE V

MEMBERSHIP

Section 1. All people who are in sympathy with the purpose of the club may have a membership.

Section 2. Persons or businesses of notable interest who support the purpose of the club may have honorary membership granted to them.

ARTICLE VI

DIRECTOR, OFFICERS and COMMITTEE CHAIRMEN

Section 1. A Director of the Club will be elected for a two year term at the Fall meeting in even years and a Treasurer in odd years. Officers will assume their new duties at the close of the Fall meeting. The Treasurer cannot be a member of the Director's family.

Section 2. A Secretary and a Membership Chairman will be appointed each for 2 year terms by the Director in cooperation with the Treasurer.

Section 3. The Director, Treasurer, Secretary and Membership Chairman will be the Executive Board. Three of the four members constitutes a quorum for any Board business.

Section 4. Other committee chairmen may be appointed for 2 year terms by the Director in cooperation with the Executive Board.

Section 5. The Executive Board and chapter presidents will be the Executive Committee.

Section 6. Chairmen and officers may hold elected positions within a chapter.

Section 7. The Director, officers and chairmen must be members in good standing with the state.

Section 8. No Director or officer may serve more than 2 terms in the same office.

Section 9. In case of a permanent vacancy in the Director's or Treasurer's office the Executive Committee will elect an interim Director or Treasurer to serve until the next regular election of that office; in case of a vacancy of appointed officers or chairmen, the Executive Board will appoint a replacement to complete the term. In case of a temporary vacancy in the Director's or Treasurer's office the Director or Treasurer may appoint a proxy.

ARTICLE VII

CHAPTERS

Section 1. A group of 3 or more memberships (rigs) may request to become a chapter of the state organization.

Section 2. A request including name of chapter, governing rules, officer's names and number of members should be sent to the Membership Chairman for review.

Section 3. A chapter's purpose and governing rules should not conflict with the governing rules of the state.

Section 4. The state will issue to a new chapter an RVers of Idaho Charter when a completed request to become a chapter has been submitted by the chapter and it has reviewed by the Executive Committee.

Section 5. New chapters will not be assessed dues for the portion of the year before November 15 in which they are chartered, but will be liable for dues the first November 15 in the year of their charter.

ARTICLE VIII

MEETINGS

Section 1. The state will hold at least two regular general membership meetings a year.

Section 2. Special meetings can be called at the request of the Director or an Executive Board member with the approval of two other members of the Executive Committee. Thirty (30) days notice must be given to the membership prior to special meetings.

Section 3. All state officers and chairmen must attend and participate in all regular and special meetings unless otherwise excused.

Section 4. All chapter presidents must attend all regular state meetings or name a proxy to attend.

ARTICLE IX

VOTING ELIGIBILITY

Each membership (rig) whose dues for the current year are paid will have one vote in their primary chapter on business of RVers of Idaho.

ARTICLE X

LOGO AND COLORS

Section 1. The colors of the club will be red and blue with white.

Section 2. The official logo of the club is:



Blue border is #0030bd (RBG 0-48-189)

Blue camper is #2f499e (RBG 47-73-158)

Red lettering is #cc0000 (RBG 204-0-0)

Grey shading is #bec0c2 (RBG 190-192-194)

Section 3. Logo must be used as is; may be used on clothing, signs, vehicles, etc., affiliated with RVers of Idaho.

ARTICLE XI AMENDMENTS

Section 1. Proposed amendments to this document should be submitted to the Director in writing at least 60 days prior to any regular meeting so they can be presented to the membership in their chapters and be voted on by each membership. The vote of individual memberships will be announced by the chapter presidents at the meeting.

Section 2. Amendments must be approved by a three-fourths (3/4) affirmative vote by the current membership in good standing. Approved amendments will go into effect immediately following the meeting.

ARTICLE XII DISSOLUTION

Section 1. The club may be discontinued at a regular meeting if agreed by an affirmative vote of three-fourths (¾) of the current membership in good standing provided 30 days prior notice of this intention is given to the membership.

Section 2. Assets remaining after all debts have been paid shall be donated to a non-profit or groups with similar purpose to RVers of Idaho on the approval of the Executive Committee.
